CLIENT engages DJPL and DJPL agrees to produce and perform the services in a competent and professional Manner according to the terms and conditions stated below, on the stated date above, for the stated compensation Below at the CLIENT'S specific site as stated above.

This agreement may be canceled , by either party, by giving twelve weeks written notice to the other party at the below stated address. Failure by the CLIENT to give written notice to DJPL by certified or registered mail will mean the CLIENT shall pay the performance fee whether DJPL performs or not. In the event DJPL is unable to perform as agreed upon and is unable to give twelve weeks notice, DJPL may arrange for a replacement show comparable to DJPL'S show at no additional charge to CLIENT.

DJPL shall not be liable for damages, either liquidated or punitive, in the event of unforeseen circumstances which prevent DJPL from performing as agreed, or from obtaining a substitute music show, and such non-performance is reasonable under the circumstances.

In the event of non-performance or failure to supply a substitute is not reasonable under the circumstances, then DJPL may be liable for liquidated and punitive damages to a sum not greater than the agreed-upon contract price.

The CLIENT shall furnish a suitable area for the production of the show on the premises stated above and shall make grounded outlets available. The CLIENT assumes responsibility for DJPL'S equipment while on the above described premises and will be responsible for the patron's or guest's conduct during DJPL'S arrival, departure and performance. DJPL reserves the right to cease performance if the performer or DJPL'S equipment or life is in jeopardy. DJPL will attempt to play music that has been requested, but will not be held liable for selections no played. CLIENT will pay for any advertising in connection with the appearance of DJPL at the function.

The above described services will be provided at a total cost of \$ _____. A non-refundable deposit of \$150.00 is payable with the return of this contract. The balance of \$ _____ shall be paid at the beginning or anytime before the show on that date.

This contract void if not returned by ____ / ____ / 20 ____ . Contract must be returned by the date stated above, but as dates fill fast, it is advisable to return contract as soon as possible to reserve your date. If not returned by date stated above, DJPL reserves right to reissue contract but not at guaranteed price stated above.
